Welcome to this season’s e-newsletter from the International Measurement Confederation, IMEKO, featuring the latest news and updates. A copy of the newsletter is also available on our website, www.imeko.org.

☞ **The SENSOR+TEST 2016 Measurement Fair** suited to this year’s special topic, “Measuring in the Cloud” (International Internet of Things Conference), is slated for May 10th to 12th, in Nuremberg, Germany. Visitors will have the opportunity of obtaining a comprehensive information on the state of art in sensors and measurement, as well as in testing technology.

The 18th edition of GM/ITG-Fachtagung “Sensoren und Messsysteme” is to be held this year, concurrently with the Measurement Fair. This excellent German-language Congress on sensor and measuring technology is jointly supported – by our German Member-Organization – the VDI/VDE-Gesellschaft Mess- und Automatisierungstechnik (GMA) and the Informations-technische Gesellschaft im VDE (ITG), and it is to be hosted by the GMA this year.

Another interesting event, which is the European Telemetry and Test Conference – etc2016, organized by the European Society of Telemetry is also being put together in association with the SENSOR+TEST in Nuremberg. The etc2016 provides a platform for telemetry, telecontrol, test instrumentation and data processing. ☞ **The e-journal, Acta IMEKO** is so far, doing well. But it accepts papers from any source and is not bound to publish only extended versions of papers presented at IMEKO conferences. 2 of such papers freely submitted were published in the year 2015.

☞ **The best papers presented at the IMEKO XXI World Congress, Prague 2015** are to be published in a Special Section of the Journal MEASUREMENT, and scheduled also for issues in Acta IMEKO in the year 2016. The submitted extended versions of the relevant World Congress papers are subject to a thorough reviewing process.

☞ **The Digital Object Identifier (DOI)** is available for IMEKO, in the first phase for Acta IMEKO papers, then in the second one, it is also prepared for conference proceedings. The IMEKO Secretariat addressed the issue of application to Crossref (<http://www.crossref.org>) for membership admission. Through the Publishers International Linking Association (PILA) Membership Agreement, our Confederation has become a member with Crossref, this February. ☞ **Other interesting news:**

The European Research Council (ERC) and the OAPEN Foundation announced their co-operation in furthering Open Access to academic books and book chapters. The OAPEN library provides a platform for the full-text dissemination of Open Access books from all scientific areas, particularly in social sciences and humanities. The ERC emphasises the need for Open Access to peer-reviewed monographs and edited collections.

Similar agreements have been already signed with key Open Access repositories in Life Sciences (Europe PubMed Central) and physical sciences and engineering (arXiv) covering most scientific domains and publication formats.

Brussels has proposed a mandatory exception for research in the EU copyright legislation in the hope of overcoming a “fragmented copyright regime” and to establish a research-friendly copyright based on the fact that scientific research is collaborative and knows no borders. The legislative package including the exception for research is planned to be released in 2016.

The European Commission proposed new digital rights to ensure better access for consumers and businesses to online content, goods and services. Also new proposals on digital contracts aim to better protect consumers when buying digital content or goods online as well as helping businesses expand their internet sales. These plans on the portability of online content will be expected to become a reality by 2017.
